Jesse H. Choper Distinguished Professor of Law at UC Berkeley School of Law, will be the guest lecturer. Dean Chemerinsky, who also serves as president of the Association of American Law Schools, is a nationally recognized legal

scholar known for his expertise in United States constitutional law and federal civil procedure. He is the author of 14 books, including leading casebooks and treatises about constitutional law, criminal procedure, and federal jurisdiction. Additionally, he has authored more than 200 law review articles, is a contributing writer for the Opinion section of the Los Angeles Times, and writes regular columns for the ABA Journal, as well as op-eds in newspapers across the country. He also frequently argues appellate cases, including in the United States Supreme Court.

Michael Green, Mel and Pam Brown Visiting Professor of Law at Washington University in St. Louis School of Law, is a nationally and internationally recognized torts teacher and scholar. He is a member of the European Group on Tort Law and is a founding member and emeritus executive committee member of the World Tort Law Society. He regularly lectures in Europe, South America, and China. In addition to his tort and products liability scholarship, he has written extensively about toxic torts and the issues of causation and apportionment that arise in those cases. His scholarly writing has appeared in outlets such as the Wake Forest Law Review, Pepperdine Law Review, UCLA Law Review, and DePaul Law Review, among many others.



Review, among others. She also co-authored a leading professional responsibility casebook, Legal Ethics, as well as the torts casebook, Tort Law and Alternatives.
